Dual Sport Athletes at CHS

- 1. Dual sport participation must be <u>initiated</u> by the student athlete by picking up a contract and information from the Athletic Director.
- 2. The student athlete must declare one sport as their primary sport and the other as their secondary sport.
 - a. Primary Sport Must attend all practices and events unless **pre-arranged** with the primary sport coach.
 - b. Secondary Sport Practices will be done at alternate times as determined by the secondary sport coach.
- 3. Secondary Sport Participation
 - a. The student athlete will need to participate in one event or competition (see below exception for swimming) in their secondary sport before competing in a conference tournament and/or W.I.A.A. tournament.
 - i. Track, Cross Country, Wrestling one meet before competing in the conference meet
 - ii. Volleyball, Football, Cheerleading, Basketball, Baseball, and Softball one game before W.I.A.A. Regional starts
 - iii. If Swimming is the secondary sport, they will need to abide by W.I.A.A. rule which requires participation in 4 meets in order to participate in the W.I.A.A.

 Sectional meet.
- 4. The student athlete must adhere to an agreed upon practice calendar between both coaches indicating both the primary and secondary practices and competitions. This will be shared with both coaches and the Athletic Director.
 - a. If one coach does not agree to this contract/calendar, the student athlete will not be allowed to participate as a dual sport athlete.
 - b. If both coaches agree to the contract/calendar, the student athlete will need to get the contract signed and turned into the athletic director *before the first practice of the earliest sport*.
- 5. If the student athlete is not fulfilling their duties and responsibilities in one or both sports and/or academically, the athlete, coach or coaches will contact the Athletic Director and a meeting will be set to discuss the situation and how to best move forward.
- 6. The dual sport athlete must adhere to all requirements of the CHS Athletic Code.
